

**RESOLUTION 2023-11**

**A RESOLUTION OF THE BOARD OF SUPERVISORS OF THE  
HARRISON RANCH COMMUNITY DEVELOPMENT DISTRICT  
SETTING THE ANNUAL MEETING SCHEDULE FOR FISCAL YEAR  
2023/2024; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, the Harrison Ranch Community Development District (the “District”) is a local unit of special-purpose government created and existing pursuant to Chapter 190, *Florida Statutes*, and situated within Manatee County, Florida; and

**WHEREAS**, the District is required by Section 189.015, *Florida Statutes*, to file quarterly, semi-annually, or annually a schedule (including date, time, and location) of its regular meetings with local governing authorities; and

**WHEREAS**, further, in accordance with the above-referenced statute, the District shall also publish quarterly, semi-annually, or annually the District’s regular meeting schedule in a newspaper of general paid circulation in the county in which the District is located; and

**WHEREAS**, the district now desires to set an annual meeting and workshop schedule for the Fiscal Year beginning October 1, 2023, and ending September 30, 2024 (“Fiscal Year 2023/2024”), which is attached as **Exhibit A**.

DEVELOPMENT DISTRICT:**

1. The Fiscal Year 2023/2024 annual meeting and workshop schedule attached hereto and incorporated by reference herein as **Exhibit A** is hereby approved, and shall be published in accordance with the requirements of Florida law and also provided to applicable governing authorities.


2. This Resolution shall become effective immediately upon its adoption.
